It is my pleasure to report to members on the Society's performance and progress for the year ending 30 June 2023 financial year.

I am pleased to report that the Board's focus on preservation and utilisation of the Society's assets, which include the Subiaco land and building, and with conduct of the J M O'Hara Research Fund (the Fund), has again proved successful.

Financial statements included in this report show the Society's net assets stood at \$2.5 million. The net assets of the J M O'Hara Research Fund stand at just under \$800,000.

The Board's efforts for the Society to be a major facilitator of pharmacy research and practice development in Western Australia continue to move in a positive direction. Research funding totalling \$173,000 has been provided over the past seven years.

The Board remains focused on its strategic plan and its governance and risk management framework as well as assiduously striving to improve the financial position of both the Society and the Fund.

PSWA 130th Anniversary

PSWA celebrated its 130th anniversary on 24 October 2022. The occasion was marked by holding a 130th Birthday Party which was considered a huge success and brought together a large number of members and stakeholders.

The Annual General Meeting and the PSWA Pharmacy Celebration were held on the anniversary of the first meeting of the Society in a historical building not far from where the original meeting was held.



JM O'Hara Research Fund

PSWA Board February the In announced a broad review of the JM O'Hara Research Fund (JMOHRF), the Society's research arm which has been providing research funding grants to members for pharmacy projects since 1976. The PSWA Board conducted a review to develop changes to the governance, structure and processes of the JMOHRF based on the feedback and advice generated from a JMOHRF stakeholder forum, member surveys and targeted member comment.

The PSWA Board thanks all the contributors, recognising the input into the review process provided wide-ranging and sometimes opposing opinions that were all well intentioned and well considered. We believe the changes that have been agreed by the PSWA Board will ensure the **JMOHRF** remains contemporary and relevant to PSWA members and stakeholders and continues to be aligned to our vision as a recognised major facilitator for pharmacy research and practice development in WA.

One of the key issues highlighted at the stakeholder forum was a need to increase the transparency of the processes of the JMOHRF. The new **JMOHRF** Governance Framework details the overarching governance, application criteria and assessment processes. The document establishment details the of realigned **JMOHRF** Advisory Committee which will be developed in 2023.

The Board's strategy to increase the Fund's ability to assist research endeavours continued to enjoy success to a level where members have contributed \$15,000 dollars this financial year through the Pharmacy 100 Club and other donations. Symbion have continued to donate \$1,000 a year since their initial commitment through the Pharmacy 100 Club.

A number of Pharmacy 100 Club members who have completed their initial 5-year commitment generously continue supporting the JMOHRF with annual donations. We also continue to ask all Society members to consider remembering the JMOHRF in their wills and provide information on our bequest program to any member who requests it.

I am confident that accomplishment of the strategy will see the J M O'Hara Research Fund remain as recognised major facilitator pharmacy research and practice development in Western Australia," which is the vision expressed in the Society's strategic plan and will give members cause enormously proud of our profession. Since its inception the Fund has provided research grants to Society members totalling over \$420,000.

I wish to thank the outgoing JMOHRF Grants Committee (GC) for their support and commitment to the JMOHRF. Thank you to Professor Carol Bower (Chair), Anna Gelavis, Dr Kim Watkins, Dr Natalia Popowicz, Wesley Williams and Belinda Frank who provided their expertise as members of the Grants Committee. I'd also like to congratulate Professor Bower, who was named a Companion of the Order of Australia in the King's birthday honours in June this year for her eminent service to medical research.

PSA Lease at 21 Hamilton St

The ten-year lease held by the Pharmaceutical Society of Australia (PSA) for the PSWA building at 21 Hamilton St concludes at the end of 2023. The PSWA Board considered a number of different scenarios and options for future use of the premises. The PSWA Board consider it is important to ensure the longevity of the Society and its forward focus of supporting pharmacy practice research in WA.

After much discussion with PSA, it was mutually agreed the premises aligned with not requirements of PSA or PSWA. In order to optimise the members investment in the premises the PSWA Board is seeking new tenants on a commercial lease. This provides a fabulous opportunity to generate a previously untapped income stream that will go towards supporting the Society and more importantly into members supporting our undertake research in pharmacy practice and innovation.

The PSWA Board acknowledge that many PSWA members have strong memories with the premises and are currently considering options for the display and storage options for the historical pharmacy book and antiquity collections. If any members are available to volunteer some time to help catalogue the library, please let us know.
